2022-23 Phase Three: Comprehensive School Improvement Plan

Rationale

School improvement efforts are a collaborative process involving multiple stakeholders. During the improvement planning process, leaders focus on priority needs, funding, and closing achievement gaps between identified subgroups of students. When implemented with fidelity, the Comprehensive School Improvement Plan (CSIP) cultivates an environment that promotes student growth and achievement.

While the focus of continuous improvement is student performance, the work must be guided by the aspects of teaching and learning that affect performance. An effective improvement process should address the contributing factors creating the learning environment (inputs) and the performance data (outcomes).

- Building Capacity in the Middle School Math Team through PLC:
 - PIMSER will be spending the day at the middle school to work with the Math Department to develop a needs assessment individualized to Walton-Verona School's needs.
 - This can still be supported by going through the process of designing a local curriculum and developing a dashboard which will display subject and grade level resources, scope and sequence
 - Using a math specialist most days.
 - Looking at the issue vertically through high-quality curriculum and resources:

- WVUSD is utilizing the newly purchased curriculum. This can still be supported by going through the process of designing a local curriculum and then selecting high-quality sources,
- Design a strong MTSS approach to ensure support for all students:
- WV has schedules/dates to chunk the KDE MTSS training to work internally with our leadership team so we can begin to design the MTSS system.

Operational Definitions

Goal: Long-term three- to five-year targets based on the five (5) required school level goals. Elementary/middle schools must have goals for proficiency, separate academic indicator, achievement gap, growth, and transition readiness. High schools must have goals for proficiency, separate academic indicator, achievement gap, graduation rate, and transition readiness. Long-term targets should be informed by the Needs Assessment for Schools.

Objective: Short-term target to be attained by the end of the current academic year. There can be multiple objectives for each goal.

Strategy: An approach to systematically address the process, practice, or condition that the school will focus its efforts upon, as identified in the Needs Assessment for Schools, in order to reach its goals or objectives. There can be multiple strategies for each objective. The strategy can be based upon Kentucky's six (6) Key Core Work Processes listed below or another established improvement approach (i.e. *Six Sigma, Shipley, Baldrige, etc.*).
